As in the European Union, enforcing punishments against citizens without prior judicial verdict is strictly illegal, there is an illegal trick which, the colonizers, may employ in order to abuse existing laws and indirectly, to perpetrate plausibly deniable abuse of authority, in order to legitimize the criminal destruction of the existing innocent and lawful, European anti-colonialism activists, like myself. The trick is, by accumulating a number of forged accusations/reports, against the targeted-individual, submitted to the security authorities by criminalized citizens, in order to cause an instrumental formal investigation against the targeted-individual which, shall, eventually, lead to the illegal punishment of, his human-rights, temporarily, becoming deprived from him or her and be transferred to, almost certainly corrupted, pseudo-"scientists" within an illegal, mandatory mental-evaluation.

The following incident, if it is not just an arbitrary one, could, probably, be a realization of such an illegal trick against me.

Here are the facts:

- I am a politically persecuted, by the Greece's dictatorial political regime, Greek refugee; an witness and victim of the "transnational organized crime's" crimes; and a witness and victim of the criminal "human-trafficking".

- On October 31th, 2020 I visited the local Police Station, at Freilassing, and I requested, according to the International laws, about the refugees; about the victims/witnesses of the "transnational organized crime"; and about the victims/witnesses of the "human-trafficking", from them to provided to me the specified protection. They replied that, for my case, responsible was the nearby Border-Police and they handed me a note with the address of the Border-Police. Then, I submitted the same request to the local Border-Police who replied that, for my case, responsible was a specialized Police-department at Munich and they handed me a note with the address of this Police-department at Munich. Since I am poor and homeless, I can't afford to pay for the travelling expenses towards Munich, so I was left unprotected and obliged, due to the cold weather conditions, to sleep into a local public-telephone cabin.

erman-government-07-11-2020&catid=27:apopseis&Itemid=62] by which, I indirectly and publicly denounced the participants of the illegal, May 21th, 1949 treaty (which de jure deprives the German Nation from its human-rights), namely the United Kingdom, the United States of America and the France, for their being committing a genocide, due to not rescuing cancer-patients while complete-cures of cancer exist, against the German Nation. In this article, I publicly claimed that, I am an impeccable citizen.

- In less than 20 hours, on November 8th, 2020, at 07:20 at Freilassing, while I was sleeping into a local public-telephone cabin, two unknown to me men, dressed in black clothes, they approached the cabin. The one kept in his hand a mobile-phone and the other one kept in his hand an object which I couldn't identify for sure though, at that time, it seemed like being a plastic toy-pistol. Then, they started kicking the windows of the cabin with strength near to the glass's braking point, while loudly laughing. As I woke-up from sleeping and became terrified, I started to overtly videotaping the incident. When they saw me videotaping them, they, temporarily, stopped kicking the cabin and, the one attempted to run away, and the other one started to speak politely, in German which I don't comprehend. Then, the polite one started to throw garbage into the cabin through a narrow opening of the door. Then, the other one hard-kicked the cabin again. Then, they used their mobile phone and called the Police. One of the Police officers informed me, if I understood well that, the two harassers called the Police and they reported me as being, allegedly, a "mental-case". Then the Police-officer told me that, they shall write in their report that they came and they found me, and they left.

For the above reasons, I kindly request from the German Government to fulfil hers legal and moral duty by providing me the legitimate protection which I am entitled to as being a politically persecuted, by the Greece's dictatorial political regime, Greek refuge; an witness and victim of the "transnational organized crime's" crimes; and a witness and victim of the criminal "human-trafficking". And to assure the German citizens that, despite their overt and unexplained disfavour against me, I shall, keep respecting them; keep loving them; and keep using all the existing legitimate means in order to, peacefully, contribute towards, their security; their well-being; and their freedom.
