Therefore, I believe that, it is profound that, Russia and because of evolutionary and historical reasons, she has become, despite some Russians good intentions, an autonomous, irrational and rogue organizational form which, in order to maintain its quasi “metabolism”, she, literary, “consumes/capitalizes” other Nations through the extinction-protocol of settler-colonialism.

Concluding, I kindly ask the reader to pray for my survival, good health and freedom, as anything more than that it seems like being beyond the abilities of the EU’s member-States to act unnoticed by the densely widespread, within the European Continent, Russian and Co. Espionage-Stations.
