04/05/2021, 01:30: The past month I was in Germany. During this month there was a sequence of incidents within my social surrounding that they seemed to comply with the definition of the criminal gang-stalking against me. And they created to me the impression that, due to my political activism, my political opponents, namely the U2RIT, they probably were attempting to fabricate forged "evidence" in order to slander me as allegedly "mentally unstable".

Initially, I chosen to temporarily ignore this email until the morning on 03/05/2021 when I gathered more information and then, I evaluated the overall situation of my presence in Germany. At that time I concluded that my personal security, during the present circumstances, it is, most probably, highly threatened, and thus I decided to depart immediately from Germany and to resort to another European State.

Now, I am rushing towards that European State and I am located in a German railway-station.

About one hour ago, I noticed a uniformed worker rolling a photogrammetric machine towards the place where I was sitting (pls see the picture above). There were no indications (labels, logos, e.g. "Google Maps", etc.) on the uniform or on the machine. These machines are being used in order for making three-dimensional 3D models of objects. For example, making the statute of a person could be automated by preparing its 3D model with such a machine.

The machine was located at around 12 meters away from me when I noticed it and I went out of its visual field, behind a solid object, until it moved away. Then, it came back four times, and all of them, I managed to promptly cover myself away of its visual field.

This train-station is a little-bit old and thus, I can not find any reason for this specific train-station to be presented through the Internet in a 3D form.

On the contrary, a 3D coloured-model of a Greek anti-colonialism political dissident, hypothetically, it could be used for fabricating forged incriminating videos against him and/or using an automated method for making a solid representation of his appearance when he passes away, e.g. due to a "failed" open-brain surgical operation.

By taking into account also some other information which I gathered earlier and, for legal reasons, I shall refrain from disclosing publicly, here is my best estimation about the current situation:

1. The A.O., A.A., G.B., L.F., and many others, perpetrated human-trafficking in Greece, on behalf of the U2RIT's member-States, and against innocent Greek children and adults, including myself. Among the heinous crimes which they committed, there is the involuntary brain-implanting of brain-locking and remote-neural-monitoring technology. Myself is one of their victims. The electronic devices in our heads are legal incriminating evidence against them. Now, the public revelations about this issue, they have gone too far and it seems that, the U2RIT

decided to, criminally and involuntarily, open surgically our head in order to arbitrarily and criminally confiscate these brain-implants, and in order to make us crippled enough, if not dead, to become unable to legally, and/or otherwise persecute them. The piece of information that I refrain from sharing is about the U2RIT's brutally and inhumanely threatening me that they plan to "open my head...". By this way, the human-traffickers they imagine that they would ever escape accountability.

2. In Greece there is a political dead-end. The U2RIT, through using as a proxy army of known Greek speaking Israelis and others, they applied genocidal policies, as means of criminal settler-colonialism, against innocent Greek civilians, resulting innumerable, unjust deaths. Now, the colonizers they seem to imagine that, by designating and biologically sacrificing, meaning murdering, a political scape-goat, e.g. myself, they would ever escape the accountability.

For the above reason I kindly request from the German, political and security, authorities and armed-forces to make sure that I shall be able to leave Germany unharmed.

Also, I kindly request from the political and security, authorities, of the destination country to make sure that I shall be able to stay there, secure and free.

However, in the case, hopefully not, that my human-rights they become violated, I request from the Greek patriots, to make use of the Greek legislation (article 120 of the Greek Constitution, self-defence, law of war-time, law of emergency, etc.), and swiftly, retaliate so intensively against the Greek speaking human-traffickers and others that, harming any lawful and innocent Greek anti-colonialism activist, like myself, to become deeply inconceivable, for the colonizers and all the others.
